Business Risks Beyond the EPL Policy

- Claims beyond Discrimination
- Business exposure created by Employees

Dishonest Employees

- Fidelity Bonds
- Special sub-limits when included in stand alone policies
- Examinations under oath
- Pursuing the employee for missing funds; set-offs?



Leveraging Your Workforce for Success

Injuries Suffered or Caused by Employees

During the course of employment

- Non-owned autos
 - specifically scheduled vehicles
- Limitations on general liability policies
 - Exclusions and Conditions

- Limitations on property policies
- Reporting the claim
 - Prejudice to the insurer resulting from late notice



Cyber Risks How to Protect Yourself

- Historically, limited coverage
- The development of stand alone policies
- Manuscript policies
- Potential exposure from minor and major security breaches



Potential Exposure and Damages

- Loss of your own data and your disaster recovery plan
- Loss of your customer's data
- Identity theft

Leveraging Your Workforce for Success

Defense Costs from Security Breach Litigation

- Self-insured retentions vs. deductibles
- Who picks defense counsel?
- Who administers the claims?



Leveraging Your Workforce for Success

Exposure to Directors, Officers and Shareholders

- Directors and Officers policies
- Can Non-competition clauses ever be covered?
- Complaints involving both covered and not covered claims

Leveraging Your Workforce for Success

Professional Liability Claims

- Typically excluded from general liability coverage
- Generally written on claims made basis, not occurrence
 - Excess / Umbrella policies

- They are not what you think they are
- Coverage reflected, not provided
